Subject: Empanelment of Visiting Team Members-reg.

Sir,

As you are aware, the National Council for Teacher Education (NCTE) has been set up by an Act of Parliament (Act No. 73 of 1993) with a view to achieve planned and coordinated development of the teacher education system throughout the country, the regulation and proper maintenance of norms and standards in the teacher education system and for matters connected therewith. The NCTE functions under the overall supervision of the Ministry of Human Resource Development, Government of India.

Section 14/15 of the NCTE Act provides for grant of recognition/permission to a new institution/already recognized institution for additional course or for additional intake. Prior to grant of recognition, the institution is required to be inspected by a team of experts called Visiting Team to verify the infrastructural and instructional facilities made available by it for a particular teacher training course.

Similarly, Section 13 of the Act provides for ascertaining as to whether the recognized institutions are functioning in accordance with the provisions of the Act. For this, the NCTE conducts inspection of an already recognized institution.

The Regional Committees of NCTE are empowered to conduct inspections u/s 14 and 15 of the NCTE Act and inspections u/s 13 are conducted by NCTE Hqrs. The Regional Committees are having their own panel of experts for conducting inspections. The NCTE Hqrs. conducts inspection from the panel of experts maintained by it.

As a step further towards e-governance and bringing transparency in the functioning, NCTE has launched an online system for empanelment of Visiting Team Members. The online system has become operational from 26th November, 2015. A User Manual has been made available on the Link for filling the online application form for empanelment of Visiting Team Members. NCTE Hqrs. will maintain a centralized data base of teacher educators and the Visiting Team will be selected by NCTE Hqrs. and the Regional Committees from the data base so maintained by NCTE Hqrs.

The application form devised for empanelment as a Visiting Team Member is exhaustive. The teacher educator is required to provide complete details with regard to his academic, professional qualifications, research & training activities etc.

You are requested to kindly give publicity to the above so that the teacher educators working in your University could submit the application online for empanelment as Visiting Team Member.
